Sarah Schaefer's compensation was reviewed by the Executive Committee in advance of the January Board meeting. The committee was presented with other Executive Director salary comparisons using several available resources, including the CA Museum Association's Salary Survey for museums in CA. They were also presented with the California Labor code that laid out the minimum required salary for exempt employees in 2023 according to the state. The committee made a recommendation to the board at the January board meeting and the salary documents were presented to the board at large. The Executive Director's 2023 salary was set and approved by the board at the January meeting as part of the budget discussion and approval process. The board also reviewed and approved a

one-time payroll adjustment for fulltime employees for unpaid exempt status.
